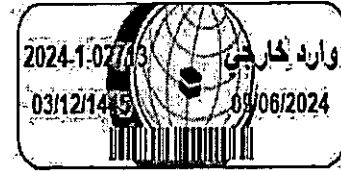

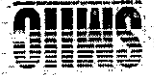

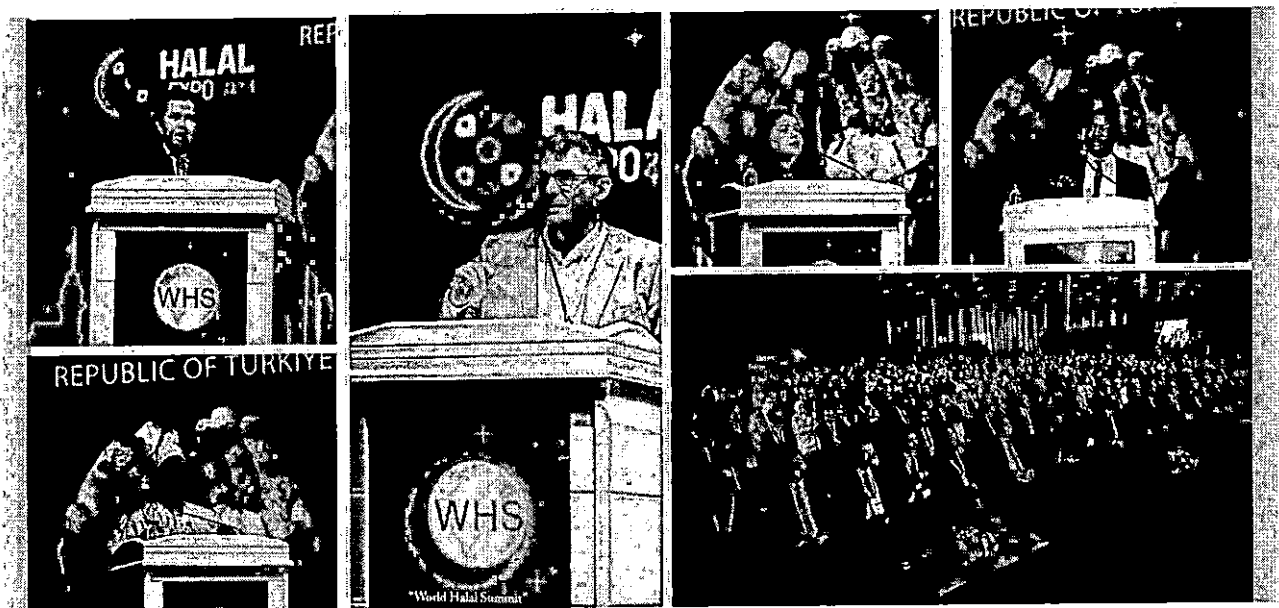

## Submission of Abstracts

All abstracts must be submitted in **English** via email to [info@worldhalalsummit.com.tr](mailto:info@worldhalalsummit.com.tr) and [secretariat@smiic.org](mailto:secretariat@smiic.org), or through the official WHS website. The submission deadline for abstracts is **August 30th, 2024**, and the email subject line must read **"WHS 2024 Abstract Submission."**

We invite potential speakers to submit their abstracts via email in either **Microsoft Word** or **PDF formats**. Along with the abstract, **it is mandatory** to include author/co-author information, institution/affiliation, and contact details such as address, email, and mobile phone number with Whatsapp number. A **brief biography/CV** must also be sent alongside the abstract, as **abstracts without a biography will not be considered**.

The notification of acceptance for selected abstracts will be announced **after September 30th, 2024**. Authors of selected abstracts will be required to submit a final manuscript and a PowerPoint presentation.



## Submission of Full Papers

After the evaluation of the full manuscript, the final notification for acceptance will be announced. The full manuscript must be written in English, be original and authentic, and must not have been published or currently being considered for publication elsewhere. The manuscript should be a maximum of 25 pages, excluding the bibliography, with 12 Times New Roman font and 1.5 spacing. The manuscript should include all notes, endnotes, and bibliography. Please submit the full manuscript as a Microsoft Word file (ext. doc/docx) to [info@worldhalalsummit.com.tr](mailto:info@worldhalalsummit.com.tr) and [secretariat@smiic.org](mailto:secretariat@smiic.org) no later than November 1st, 2024.



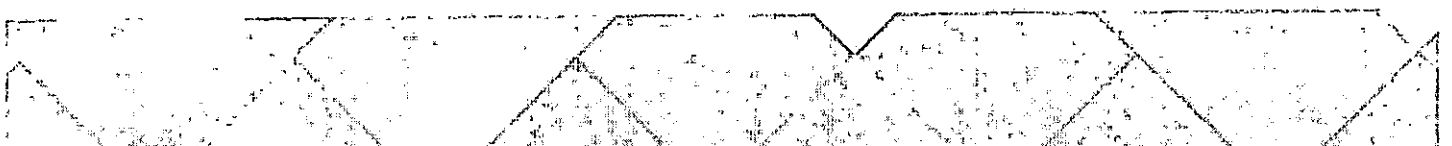
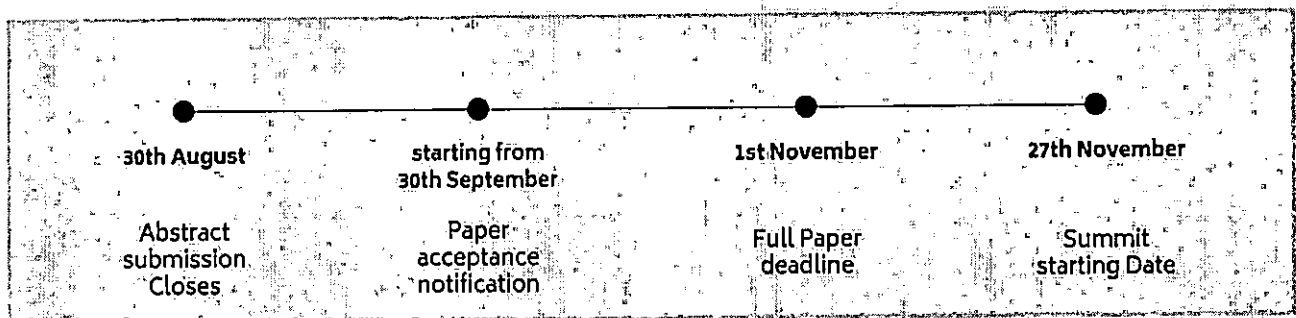
